I, *(print your name)* \_\_\_\_\_, have read and completely understand the following instructions that I must carry out as a neighbor to allow the fumigation to proceed. I acknowledge that without my signature approval and assistance the fumigation will be cancelled.

1. **COMMON FENCES** – Three or four of the fence boards next to the support post and the top rail of the fence will need to be detached to allow the fume tarps to seal to the ground, around the structure to be fumigated. Driskell Fumigation, Inc. has a professional Prep Department that will detach the necessary fence boards and re-attach all fence boards to original form after the fumigation has been completed.

If you have pets that stay in your yard it will be necessary to make arrangements for them because the fumigation process may take a couple of days. If you have cats, please make sure that you keep them in a safe place because your cat may get curious and decide to investigate and/or hide in our fume tarps. We at Driskell Fumigation, Inc. want to take all measures to prevent a tragedy from occurring.

2. **STORED ITEMS** – Items stored in this vicinity will need to be removed during the fumigation process to provide a clear area for our crew and their equipment.
3. **PLANTS** – Our crew and equipment require a certain amount of space to perform the fumigation properly. Driskell Fumigation, Inc. has a professional Prep Department that will trim and pull back plants that are necessary to provide the clearance required to perform the fumigation.

Thank you so much for your cooperation in our efforts to eliminate the damages caused by the infestation of drywood termites (or other wood destroying pests).
